hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the county of Kent by adding the byway open to all traffic:

Beginning on Dane Hill Road at Dane Farm, in the parish of Barham (on the parish boundary with Elham), at a turn in the road from northwest to northeast (Ordnance Survey grid reference TR17594787), and proceeds northwest initially along a well-defined way between the buildings of Dane Farm and partly enclosed, uphill for 250m to join the track along the eastern boundary of Peafield Wood (TR17424805), then turning southwest to follow that track for 30m to the junction with Peafield Wood Road, at a turn in the road from northeast to northwest (TR17404802).
